8.1 DISCUSSION AND POSSIBLE ACTION REGARDING AN AMENDMENT TO THE TOWN OF APPLE VALLEY DEVELOPMENT CODE REGARDING ACCESSORY BUILDINGS AND STRUCTURES

Lori Lamson, Assistant Town Manager, presented the staff report as filed with the Town Clerk.

It was the consensus of the Town Council to direct staff to proceed with initiation of a Development Code Amendment for Accessory Buildings and Structures.

8.2 BUDGET WORKSHOP 2021/2022

Receive and provide direction to staff

Sydnie Harris, Director of Finance, presented the staff report as filed with the Town Clerk.

Doug Robertson, Town Manager, spoke of ways to increase revenue for the golf course moving forward. In addition, he commented on the \$15 million stimulus package that the Town will receive that could assist with budget shortfalls. He explained that any funds used from the stimulus must be Covid related or due to Covid. He gave examples of projects that would qualify for funding using these funds. He stated that the Town would be required to develop a spending plan and upon approval, the Town would received one-half of the stimulus within 60 days and the second half one year later. He explained that based on uncertainty with the amount of funding that the Town will be receiving through anticipated revenues, stimulus and again, its use, he recommended not proposing cuts at this time. Council Member Nassif expressed concern regarding whether or not the anticipated funding would solve our revenue shortfalls.

Discussion ensued regarding other proposed projects in which stimulus funding could be used.

It was the consensus of the Town Council after further review and recommendations to bring back the Town Budget for approval at the meeting of June 22, 2021.

10. Town Manager's Comments & Legislative Update

Doug Robertson, Town Manager, announced that the Town had submitted a letter of support for SB792, a bill that requires online businesses to track the origin of purchase for sales tax purposes. He thanked all those who participated in the Chayce Beckham Home Town Tour event that was held at Horseman's Center.

Mr. Robertson announced upcoming events including the "Welcome Back to Summer" event on Saturday at Civic Center Park, the pool reopening also on Saturday and the Memorial Day events on Monday. He also announced that the apple tree planted at the Chayce Beckham event had been moved just north of the pool in Civic Center Park. He explained the logistics of moving the tree after the event for it's survival.
