RECOMMENDED ACTION

A. Excuse the Low Bidder, GM Sager Construction Co., Inc., per the authority granted in the Public Contracts Code Section 5106;

B. Award a contract to Onyx Paving Company, Inc. for the Resurfacing 2021-Roadway Repair Project subject to "Approval as to Form" by the Town Attorney and "Approval as to Content" by the Town Manager.

BACKGROUND

As part of the Town's annual paving priorities, staff evaluated local roadways and determined priority areas in need of maintenance. To prepare for the Town's larger resurfacing project in the summer of 2021, staff identified segments within the project area with large gap locations and other areas in need of repair. The Project generally consists of providing the necessary labor, equipment, and materials to remove damaged asphalt, replace it with new asphalt, and repair potholes with hot mix asphalt on local roads as specified in the Technical Specifications. Most of the street segments will then be resurfaced as part of the summer resurfacing project in Fiscal Year 2021/2022. The remaining segments will be resurfaced in FY 2022/2023.

On May 27, 2021, the Town received and opened bids for the subject project. The bid results are as follows:

1. GM Sager Construction Co., Inc.	\$542,500.00
2. Onyx Paving Company, Inc.	\$596,000.00
3. TLG Paving Company, Inc.	\$631,089.00
4. All American Asphalt, Inc.	\$684,517.00

On June 1, 2021, GM Sager's representative contacted Engineering staff stating that they misinterpreted the scope of work and their current workload will prevent them from completing the work within the allotted 45 days contract time. They requested, in writing, that they be excused from the project without relinquishing their bid bond. Since completion of the project prior to the Town's larger resurfacing project, which is scheduled to begin in August 2021, is critical, staff recommends approving their request.

ANALYSIS

The bid documents for the projects were reviewed by staff for accuracy and constructability. Staff reviewed the bid submissions for completeness and considers Onyx Paving Company, Inc. to be a qualified, responsible and responsive bidder.

FISCAL IMPACT

Funding for this project has been appropriated in the adopted FY 2020-2021 budget.
